



**Pet Care Agreement**

1. This is an agreement between The Paw and the pet owner whose signature appears below (herein after called "Owner").
2. Owner agrees to pay the rate for pet care provided in effect on the date pet is checked into *The Paw*.
3. Owner agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the period said pet is in the care of The Paw.
4. Owner agrees that the pet shall not leave the facility until all charges due are paid by Owner or proper payment arrangements are agreed upon by both parties.
5. **By signing this Agreement and leaving pet with The Paw, Owner certifies to the accuracy of all information given about said pet. The Paw shall exercise reasonable care for the pet delivered by the Owner to the pet care provider. Owner Further understands and agrees that dogs can receive minor cuts and scratches in the play groups they participate in while at The Paw, and any problems that develop with owner's pet(s) will be treated as deemed best by staff of The Paw at their sole discretion, and that owner assumes full financial responsibility for any and all expenses involved. If interactive daycare or swimming pool activity is provided, Owner recognizes and accepts potential risks involved in such activity. The Owner further agrees to be solely responsible for any and all acts of behavior of said pet while it is in the care of the pet care provider, or on the Paw Property in the care of the Owner. The owner is also responsible for payment of costs for injury to staff, any persons, other animals or damage to facilities caused by the pet while in the care of the owner.**

The Owner is responsible for disclosing any behavior issues of the pet(s) including pet or human aggression. A pet must possess a temperament that allows The Paw staff to safely care for the pet. If any person is bitten by Owner's pet(s) while the pet is on The Paw property, and the injury requires medical attention, the incident will be reported to the proper authorities. The Owner agrees that The Paw is NOT responsible for any items brought in with Owner's pet(s) that may be lost, damage, or eaten. The owner further agrees that services provided are done so without liability to The Paw for loss or damage from disease, death, running away, theft, fire, or other unavoidable causes.

6. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
7. Owner specifically represents to The Paw that, to Owner's knowledge, the pet has not been exposed to any contagious diseases within a thirty day period prior to check in. During the period of this Agreement, Owner also agrees to notify The Paw of any known exposure of pet to a communicable disease and hold pet out of attending The Paw until pet is symptom free for 30 days, or with written veterinary clearance. Owner further agrees to maintain currency of vaccinations as required by The Paw.
8. All charges incurred by Owner shall be payable upon pickup of pet. The Paw shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from services provided by The Paw. The Owner hereby agrees that in the event the charges are not paid when due in accordance with this contract , The Paw may exercise its lien rights upon ten days, written notice given by The Paw to Owner by certified mail to address shown on contract. The Paw may take the following actions for any and all unpaid charges: The Paw may sell the pet at private or public sale, in the sole discretion of The Paw, and Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of pet care or other charges delinquent, plus costs of sale, then owner shall be liable to The Paw for the difference. All monies realized by The Paw at such sale over and above charges due and costs of sale shall be paid to Owner.
9. Owner agrees that The Paw reserves the right to add additional fees to daily rates due to additional services required or for unruly behavior by dogs as needed without Owner's previous consent.
